### AN ACT

To amend chapter 66, RSMo, by adding thereto one new section relating to the St. Louis Airport Oversight Commission.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Chapter 66, RSMo, is amended by adding thereto one new section, to be known as section 66.420, to read as follows:

**66.420. 1. As used in this section, the following terms mean:**

(1) "International airport", any international airport located in any county with a charter form of government and with more than nine hundred fifty thousand inhabitants or any city not within a county;

(2) "Outlying property", property of an international airport that is not used as a control tower, parking lot, runway, taxiway, or terminal.

2. There is hereby established the "St. Louis Airport Oversight Commission" whose purpose is to review any decision by the governing body of an international airport regarding any outlying property that may substantially affect property neighboring the outlying property.

3. The commission shall consist of ten members as follows:

(1) Two members appointed by the governing body of any home rule city with more than eight thousand but fewer than nine thousand inhabitants and located in any county with a charter form of government and with more than nine hundred fifty thousand inhabitants;

(2) Two members appointed by the governing body of any home rule city with more than ten thousand but fewer than eleven thousand nine hundred inhabitants and located

18 in any county with a charter form of government and with more than nine hundred fifty  
19 thousand inhabitants;

20 (3) One member appointed by the governing body of any city of the fourth  
21 classification with more than eight hundred but fewer than nine hundred inhabitants and  
22 located in any county with a charter form of government and with more than nine hundred  
23 fifty thousand inhabitants;

24 (4) One member appointed by the governing body of any home rule city with more  
25 than twenty-four thousand but fewer than twenty-seven thousand inhabitants;

26 (5) Two members appointed by the governing body of any city of the fourth  
27 classification with more than two hundred eighty-five but fewer than three hundred twenty  
28 inhabitants and located in any county with a charter form of government and with more  
29 than nine hundred fifty thousand inhabitants;

30 (6) One member appointed by the governing body of any city of the fourth  
31 classification with more than twelve thousand but fewer than thirteen thousand five  
32 hundred inhabitants and located in any county with a charter form of government and  
33 with more than nine hundred fifty thousand inhabitants; and

34 (7) One member appointed by the governing body of any city of the fourth  
35 classification with more than four thousand but fewer than four thousand five hundred  
36 inhabitants and located in any county with a charter form of government and with more  
37 than nine hundred fifty thousand inhabitants.

38 4. The commission shall have veto power over any decision by the governing  
39 structure of the international airport or by any city not within a county regarding the  
40 airport.

41 5. The commission shall meet at least weekly to review and vote on any decision.  
42 The meeting shall be held at the city hall of each city represented on the commission on an  
43 alternating basis. Notice of the meeting shall be provided as required by law.
