

HB 1571 -- LIMITED LIABILITY COMPANIES

SPONSOR: Davis

This bill specifies that a member's interest in a limited liability company cannot be foreclosed upon in order to satisfy payments owed to a judgment creditor by that member.

This bill is the same as HB 408 (2017) and HB 1567 (2016).
