1 AMEND House Committee Substitute for Senate Committee Substitute for Senate Bill No. 147,
2 Page 9, Section 301.010, Line 303, by inserting the following after all of said section and line:

4 "301.020. 1. Every owner of a motor vehicle or trailer, which shall be operated or driven
5 upon the highways of this state, except as herein otherwise expressly provided, shall annually file,
6 by mail or otherwise, in the office of the director of revenue, an application for registration on a
7 blank to be furnished by the director of revenue for that purpose containing:

8 (1) A brief description of the motor vehicle or trailer to be registered, including the name of
9 the manufacturer, the vehicle identification number, the amount of motive power of the motor
10 vehicle, stated in figures of horsepower and whether the motor vehicle is to be registered as a motor
11 vehicle primarily for business use as defined in section 301.010;

12 (2) The name, the applicant's identification number and address of the owner of such motor
13 vehicle or trailer;

14 (3) The gross weight of the vehicle and the desired load in pounds if the vehicle is a
15 commercial motor vehicle or trailer.

16 2. If the vehicle is a motor vehicle primarily for business use as defined in section 301.010
17 and if such vehicle is [five] ten years of age or less and has less than one hundred fifty thousand
18 miles on the odometer, the director of revenue shall retain the odometer information provided in the
19 vehicle inspection report, and provide for prompt access to such information, together with the
20 vehicle identification number for the motor vehicle to which such information pertains, for a period
21 of [five] ten years after the receipt of such information. This section shall not apply unless:

22 (1) The application for the vehicle's certificate of ownership was submitted after July 1,
23 1989; and

24 (2) The certificate was issued pursuant to a manufacturer's statement of origin.

25 3. If the vehicle is any motor vehicle other than a motor vehicle primarily for business use, a
26 recreational motor vehicle, motorcycle, motortricycle, autocycle, bus, or any commercial motor
27 vehicle licensed for over twelve thousand pounds and if such motor vehicle is [five] ten years of age
28 or less and has less than one hundred fifty thousand miles on the odometer, the director of revenue
29 shall retain the odometer information provided in the vehicle inspection report, and provide for
30 prompt access to such information, together with the vehicle identification number for the motor
31 vehicle to which such information pertains, for a period of [five] ten years after the receipt of such
32 information. This subsection shall not apply unless:

33 (1) The application for the vehicle's certificate of ownership was submitted after July 1,
34 1990; and

35 (2) The certificate was issued pursuant to a manufacturer's statement of origin.

36 4. If the vehicle qualifies as a reconstructed motor vehicle, motor change vehicle, specially

1 constructed motor vehicle, non-USA-std motor vehicle, as defined in section 301.010, or prior
2 salvage as referenced in section 301.573, the owner or lienholder shall surrender the certificate of
3 ownership. The owner shall make an application for a new certificate of ownership, pay the
4 required title fee, and obtain the vehicle examination certificate required pursuant to subsection 9 of
5 section 301.190. If an insurance company pays a claim on a salvage vehicle as defined in section
6 301.010 and the owner retains the vehicle, as prior salvage, the vehicle shall only be required to
7 meet the examination requirements under subsection 10 of section 301.190. Notarized bills of sale
8 along with a copy of the front and back of the certificate of ownership for all major component parts
9 installed on the vehicle and invoices for all essential parts which are not defined as major
10 component parts shall accompany the application for a new certificate of ownership. If the vehicle
11 is a specially constructed motor vehicle, as defined in section 301.010, two pictures of the vehicle
12 shall be submitted with the application. If the vehicle is a kit vehicle, the applicant shall submit the
13 invoice and the manufacturer's statement of origin on the kit. If the vehicle requires the issuance of
14 a special number by the director of revenue or a replacement vehicle identification number, the
15 applicant shall submit the required application and application fee. All applications required under
16 this subsection shall be submitted with any applicable taxes which may be due on the purchase of
17 the vehicle or parts. The director of revenue shall appropriately designate "Reconstructed Motor
18 Vehicle", "Motor Change Vehicle", "Non-USA-Std Motor Vehicle", or "Specially Constructed
19 Motor Vehicle" on the current and all subsequent issues of the certificate of ownership of such
20 vehicle.

21 5. Every insurance company that pays a claim for repair of a motor vehicle which as the
22 result of such repairs becomes a reconstructed motor vehicle as defined in section 301.010 or that
23 pays a claim on a salvage vehicle as defined in section 301.010 and the owner is retaining the
24 vehicle shall in writing notify the owner of the vehicle, and in a first party claim, the lienholder if a
25 lien is in effect, that he is required to surrender the certificate of ownership, and the documents and
26 fees required pursuant to subsection 4 of this section to obtain a prior salvage motor vehicle
27 certificate of ownership or documents and fees as otherwise required by law to obtain a salvage
28 certificate of ownership, from the director of revenue. The insurance company shall within thirty
29 days of the payment of such claims report to the director of revenue the name and address of such
30 owner, the year, make, model, vehicle identification number, and license plate number of the
31 vehicle, and the date of loss and payment.

32 6. Anyone who fails to comply with the requirements of this section shall be guilty of a
33 class B misdemeanor.

34 7. An applicant for registration may make a donation of one dollar to promote a blindness
35 education, screening and treatment program. The director of revenue shall collect the donations and
36 deposit all such donations in the state treasury to the credit of the blindness education, screening and
37 treatment program fund established in section 209.015. Moneys in the blindness education,
38 screening and treatment program fund shall be used solely for the purposes established in section
39 209.015; except that the department of revenue shall retain no more than one percent for its
40 administrative costs. The donation prescribed in this subsection is voluntary and may be refused by
41 the applicant for registration at the time of issuance or renewal. The director shall inquire of each
42 applicant at the time the applicant presents the completed application to the director whether the
43 applicant is interested in making the one dollar donation prescribed in this subsection.

44 8. An applicant for registration may make a donation of one dollar to promote an organ
45 donor program. The director of revenue shall collect the donations and deposit all such donations in
46 the state treasury to the credit of the organ donor program fund as established in sections 194.297 to
47 194.304. Moneys in the organ donor fund shall be used solely for the purposes established in
48 sections 194.297 to 194.304, except that the department of revenue shall retain no more than one
49 percent for its administrative costs. The donation prescribed in this subsection is voluntary and may

1 be refused by the applicant for registration at the time of issuance or renewal. The director shall
 2 inquire of each applicant at the time the applicant presents the completed application to the director
 3 whether the applicant is interested in making the one dollar donation prescribed in this subsection.";

 6 Further amend said bill, Page 11, Section 301.030, Line 46, by inserting the following after all of
 7 said section and line:

 9 "301.191. 1. When an application is made for an original Missouri certificate of ownership
 10 for a previously untitled trailer [sixteen feet or more in length] which is stated to be homemade, the
 11 applicant shall present a certificate of inspection as provided in this section. No certificate of
 12 ownership shall be issued for such a homemade trailer if no certificate of inspection is presented.

13 2. As used in this section, "homemade" means made by a person who is not a manufacturer
 14 using readily distinguishable manufacturers' identifying numbers or a statement of origin.

15 3. Every person constructing a homemade trailer [sixteen feet or more in length] shall obtain
 16 an inspection from the sheriff of his or her county of residence or from the Missouri state highway
 17 patrol prior to applying for a certificate of ownership. If the person constructing the trailer sells or
 18 transfers the trailer prior to applying for a certificate of ownership, the sheriff's or the Missouri state
 19 highway patrol's certificate of inspection shall be transferred with the trailer.

20 4. A fee of [ten] twenty-five dollars shall be paid for the inspection. If the inspection is
 21 completed by the sheriff, the proceeds from the inspections shall be deposited by the sheriff within
 22 thirty days into the county law enforcement fund if one exists; otherwise into the county general
 23 revenue fund. If the inspection is completed by the Missouri state highway patrol, the applicant
 24 shall pay the [ten] twenty-five dollar inspection fee to the director of revenue at the time of
 25 application for a certificate of ownership for the homemade trailer. The fee shall be deposited in the
 26 state treasury to the credit of the state highway fund.

27 5. The sheriff or Missouri state highway patrol shall inspect the trailer and certify it if the
 28 trailer appears to be homemade. The sheriff or Missouri state highway patrol may request the owner
 29 to provide any documents or other evidence showing that the trailer was homemade. When a trailer
 30 is certified by the sheriff, the sheriff may stamp a permanent identifying number in the tongue of the
 31 frame. The certificate of inspection shall be on a form designed and provided by the director of
 32 revenue.

33 6. Upon presentation of the certificate of inspection and all applicable documents and fees
 34 including the identification plate fee provided in section 301.380, the director of revenue shall issue
 35 a readily distinguishable manufacturers' identifying number plate. The identification number plate
 36 shall be affixed to the tongue of the trailer's frame.

37 7. The sheriff or Missouri state highway patrol may seize any trailer which has been stolen
 38 or has identifying numbers obliterated or removed. The sheriff or Missouri state highway patrol
 39 may hold the trailer as evidence while an investigation is conducted. The trailer shall be returned if
 40 no related criminal charges are filed within thirty days or when the charges are later dropped or
 41 dismissed or when the owner is acquitted."; and

 43 Further amend said bill, Page 12, Section 302.026, Line 10, by inserting after all of said section and
 44 line the following:

 46 "307.350. 1. The owner of every motor vehicle as defined in section 301.010 which is
 47 required to be registered in this state, except:

48 (1) Motor vehicles having less than one hundred fifty thousand miles, for the [five-year] ten-
 49 year period following their model year of manufacture, excluding prior salvage vehicles

1 immediately following a rebuilding process and vehicles subject to the provisions of section
2 307.380;

3 (2) Those motor vehicles which are engaged in interstate commerce and are proportionately
4 registered in this state with the Missouri highway reciprocity commission, although the owner may
5 request that such vehicle be inspected by an official inspection station, and a peace officer may stop
6 and inspect such vehicles to determine whether the mechanical condition is in compliance with the
7 safety regulations established by the United States Department of Transportation; and

8 (3) Historic motor vehicles registered pursuant to section 301.131;

9 (4) Vehicles registered in excess of twenty-four thousand pounds for a period of less than
10 twelve months;

11
12 shall submit such vehicles to a biennial inspection of their mechanism and equipment in accordance
13 with the provisions of sections 307.350 to 307.390 and obtain a certificate of inspection and
14 approval and a sticker, seal, or other device from a duly authorized official inspection station. The
15 inspection, except the inspection of school buses which shall be made at the time provided in section
16 307.375, shall be made at the time prescribed in the rules and regulations issued by the
17 superintendent of the Missouri state highway patrol; but the inspection of a vehicle shall not be
18 made more than sixty days prior to the date of application for registration or within sixty days of
19 when a vehicle's registration is transferred; however, if a vehicle was purchased from a motor
20 vehicle dealer and a valid inspection had been made within sixty days of the purchase date, the new
21 owner shall be able to utilize an inspection performed within ninety days prior to the application for
22 registration or transfer. Any vehicle manufactured as an even-numbered model year vehicle shall be
23 inspected and approved pursuant to the safety inspection program established pursuant to sections
24 307.350 to 307.390 in each even-numbered calendar year and any such vehicle manufactured as an
25 odd-numbered model year vehicle shall be inspected and approved pursuant to sections 307.350 to
26 307.390 in each odd-numbered year. The certificate of inspection and approval shall be a sticker,
27 seal, or other device or combination thereof, as the superintendent of the Missouri state highway
28 patrol prescribes by regulation and shall be displayed upon the motor vehicle or trailer as prescribed
29 by the regulations established by him. The replacement of certificates of inspection and approval
30 which are lost or destroyed shall be made by the superintendent of the Missouri state highway patrol
31 under regulations prescribed by him.

32 2. For the purpose of obtaining an inspection only, it shall be lawful to operate a vehicle
33 over the most direct route between the owner's usual place of residence and an inspection station of
34 such owner's choice, notwithstanding the fact that the vehicle does not have a current state
35 registration license. It shall also be lawful to operate such a vehicle from an inspection station to
36 another place where repairs may be made and to return the vehicle to the inspection station
37 notwithstanding the absence of a current state registration license.

38 3. No person whose motor vehicle was duly inspected and approved as provided in this
39 section shall be required to have the same motor vehicle again inspected and approved for the sole
40 reason that such person wishes to obtain a set of any special personalized license plates available
41 pursuant to section 301.144 or a set of any license plates available pursuant to section 301.142, prior
42 to the expiration date of such motor vehicle's current registration.

43 4. Notwithstanding the provisions of section 307.390, violation of this section shall be
44 deemed an infraction.

45 Section B. Sections 301.020, 301.191, and 307.350 of Section A of this act shall become
46 effective January 1, 2020."; and
