1 AMEND House Amendment No. ____ to House Bill No. 584, Page 1, Line 4, by deleting all of
2 said line and inserting in lieu thereof the following:

4 ""301.210. 1. In the event of a sale or transfer of ownership of a motor vehicle or trailer for
5 which a certificate of ownership has been issued, the holder of such certificate shall endorse on the
6 same an assignment thereof, with warranty of title in form printed thereon, and prescribed by the
7 director of revenue, with a statement of all liens or encumbrances on such motor vehicle or trailer,
8 and deliver the same to the buyer at the time of the delivery to him of such motor vehicle or trailer;
9 provided that, when the transfer of a motor vehicle, trailer, boat or outboard motor occurs within a
10 corporation which holds a license to operate as a motor vehicle or boat dealer pursuant to sections
11 301.550 to 301.575, the provisions of subdivision (3) of subsection 6 of section 144.070 shall not
12 apply.

13 2. The buyer shall then present such certificate, assigned as aforesaid, to the director of
14 revenue, at the time of making application for the registration of such motor vehicle or trailer,
15 whereupon a new certificate of ownership shall be issued to the buyer, the fee therefor being that
16 prescribed in subsection 5 of section 301.190.

17 3. If such motor vehicle or trailer is sold to a resident of another state or country, or if such
18 motor vehicle or trailer is destroyed or dismantled, the owner thereof shall immediately notify the
19 director of revenue. Certificates when so signed and returned to the director of revenue shall be
20 retained by the director of revenue and all certificates shall be appropriately indexed so that at all
21 times it will be possible for him to expeditiously trace the ownership of the motor vehicle or trailer
22 designated therein.

23 4. It shall be unlawful for any person to buy or sell in this state any motor vehicle or trailer
24 registered under the laws of this state, unless, at the time of the delivery thereof, there shall pass
25 between the parties such certificates of ownership with an assignment thereof, as provided in this
26 section, and the sale of any motor vehicle or trailer registered under the laws of this state, without
27 the assignment of such certificate of ownership, shall be fraudulent and void.

28 5. Before the sale or transfer of ownership of a motor vehicle or trailer is complete, the
29 buyer shall sign a waiver that has substantively the following language:
30 I am aware that a vehicle purchased in the state of Missouri has a state sales tax of 4.225% and an
31 additional local sales tax. I acknowledge and affirm that these amounts are due and owed to the
32 state of Missouri and to my county of residence within 30 days of purchase. I understand that
33 failure to pay within the allotted time will subject me to fines for my inability to secure a license
34 plate in an amount equal to \$25 for every 30 days I fail to pay and a maximum fine of \$200. I also

1 acknowledge that it is illegal to drive a vehicle in the state of Missouri without properly insuring the
2 vehicle.
3 Section B. Because immediate action is necessary to ensure the safety of all users of Missouri"; and

5 Further amend said amendment Page 1, Lines 5 and 7, by inserting in front of the words, "section
6 A" the following words and number "section 136.055 of"; and

8 Further amend said bill by amending the title, enacting clause, and intersectional references
9 accordingly.
