2 for Senate Committee Substitute for Senate Bill No. 523, Page 1, Line 6, by deleting said line and
3 inserting in lieu thereof the phrase "(10) To refer to the Missouri state highway patrol and local";

6 Further amend said amendment, Pages 1, Line 16, to Page 2, Line 28, Section 311.680, by removing
7 all of said section and lines from the amendment; and

9 Further amend said amendment, Page 5, Lines 33, by deleting the phrase "investigating illegal
10 gambling pursuant to chapter 572"; on said line; and

12 Further amend said amendment, Pages 6, Line 37 to Page 7, Line 10, by deleting all of said lines
13 and inserting in lieu thereof the following:

15 "applicants or licensees applying to any gaming commission of this state."; and"; and

17 Further amend said amendment, Page 8, Line 1, to Page 10, Line 13, Sections 572.010, 572.015, and
18 572.100, by removing all of said sections from the amendment and inserting in lieu thereof the
19 following:

21 "572.015. 1. Nothing in this chapter prohibits constitutionally authorized activities under
22 Article III, Sections 39(a) to 39(f) of the Missouri Constitution.

23 2. For the purposes of this section and Article III, Section 39(f) of the Missouri Constitution,
24 the following terms shall mean:

25 (1) "Net proceeds", the gross amount paid for tickets for a raffle or sweepstakes minus the
26 payment of prizes and administrative expenses. Administrative expenses includes the purchase of
27 prizes and the purchase or rental of supplies and equipment utilized in conducting the raffle or
28 sweepstakes, and this amount shall not exceed fifty percent (50%) of the gross amount paid for
29 tickets for the raffle or sweepstakes;

30 (2) "Raffle" or "sweepstakes", the award by chance of one or more prizes to one or more
31 persons among a group of persons who have paid or promised something of value in exchange for a
32 ticket that represents one or more equal chances to win a prize;

33 (3) "Sponsor", the offering of a raffle or sweepstakes by an organization recognized as
34 charitable or religious pursuant to federal law in which the entire net proceeds of such raffle or

1 sweepstakes shall be exclusively devoted to the lawful purposes of the organization permitted to
2 conduct the raffle or sweepstakes.

3 572.020. 1. A person commits the offense of gambling if he or she knowingly engages in
4 gambling.

5 2. The offense of gambling is a class C misdemeanor unless:

6 (1) It is committed by a professional player, in which case it is a class A misdemeanor; or

7 (2) The person knowingly engages in gambling with a child less than seventeen years of
8 age, in which case it is a class B misdemeanor.

9 3. Notwithstanding any other provisions of this section, Chapter 572, or other provisions of
10 law to the contrary, fraternal organizations, or patrons thereof who are over the age of eighteen years
11 old, shall not be charged with any crime or be subject to any civil penalty or enforcement action
12 related to the use, operation, or possession of a gambling device that includes a preview of the
13 outcome and displays such outcome to the user. The exceptions of this subsection shall apply
14 without regard to whether the gaming device is approved by the Missouri gaming commission or
15 state lottery commission."; and"; and

17 Further amend said amendment, Page 10, Lines 19 and 22, by deleting each occurrence of the
18 phrase "311.680," on said lines; and

19
20 Further amend said amendment, Page 10, Lines 19 and 23, by deleting each occurrence of the
21 phrase "572.010," on said lines; and

22
23 Further amend said amendment, Page 10, Lines 20 and 23, by deleting each occurrence of the
24 phrase "572.015, and 572.100" on said lines and inserting in lieu thereof the phrase "572.015, and
25 572.020"; and

26
27 Further amend said bill by amending the title, enacting clause, and intersectional references
28 accordingly.
