## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Elementary and Secondary Education** assume the proposal will likely have an impact on local school districts. DESE defers to school districts regarding the extent of any impact.

Officials from the **Department of Higher Education** assume the proposal will have no fiscal impact on their organization.

Officials from the **State Technical College of Missouri** and the **St. Charles Community College** each assume the proposal will have no fiscal impact on their respective organizations.

In response to a similar proposal, Perfected HCS for HB Nos. 743 & 673 (2019), officials from **Lee's Summit R-7 School District** assumed this proposal would result in a fiscal impact of less than \$100,000.

In response to a similar proposal, Perfected HCS for HB Nos. 743 & 673 (2019), officials from the **Missouri State University** assumed the proposal would have no fiscal impact on their organization.

In response to a similar proposal, HB 743 (2019), officials from the **Wellsville-Middletown R-1 School District**, **Francis Howell School District** and the **University of Central Missouri** each assumed the proposal would have no fiscal impact on their respective organizations.

In response to a similar proposal, HB 743 (2019), officials from **Lewis County C-1 Schools** stated that there would be an undisclosed increase in legal fees associated with this proposal.

In response to a similar proposal, HB 1940 (2018), officials from the **Kirksville R-III School District**, **West Plains School District** and **Missouri Western State University** each assumed the proposal would have no fiscal impact on their organization.

**Oversight** notes that the most of responding organizations stated the proposal would not have a direct fiscal impact on their organization. Oversight assumes that any increase in legal fees could be absorbed with existing resources; therefore, Oversight assumes the proposal will result in no fiscal impact.

**Oversight** received a limited number of responses from school districts related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information

available. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.

**Oversight** only reflects the responses that we have received from state agencies and political subdivisions; however, other school districts were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.
