# **ASSUMPTION**

§§190.6060and 190.612 - Outside the hospital do-not-resuscitate orders from other states

Oversight notes the Department of Health and Senior Services, the St. Louis County Department of Justice Services and the Springfield Police Department have stated the proposal would not have a direct fiscal impact on their organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these organizations.

**Oversight** only reflects the responses that we have received from state agencies and political subdivisions; however, other ambulance districts, fire departments, sheriffs' offices and police departments were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.
