AN ACT

To amend chapter 42, RSMo, by adding thereto one new section relating to veterans.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 42, RSMo, is amended by adding thereto one new section, to be
2 known as section 42.145, to read as follows:

42.145. 1. As used in this section, the following terms mean:

2 **(1) "Care facility", an assisted living facility, intermediate care facility, residential**
3 **care facility, or skilled nursing facility, as those terms are defined under section 198.006;**

4 **(2) "Eligible veteran", any veteran who is approved for admission into a Missouri**
5 **veterans' home under section 42.105 but who has not been admitted to a Missouri veterans'**
6 **home due to a lack of vacancy;**

7 **(3) "Veteran housing cost", the average cost paid by the state of Missouri to house**
8 **one veteran in a Missouri veterans' home for one month, as determined by the commission.**

9 **2. An eligible veteran may elect to receive, and the commission shall issue, a**
10 **monthly voucher to be used to pay for room and board costs of any care facility licensed**
11 **under sections 198.003 to 198.189. The amount of the voucher shall be equal to the veteran**
12 **housing cost. Vouchers shall be issued monthly or at a longer interval chosen by the**
13 **commission, so long as veterans residing at a care facility can pay room and board costs**
14 **in a timely manner. The issuance of a voucher shall not affect any eligible veteran's**
15 **position in the queue for a Missouri veterans' home vacancy.**

16 **3. The commission shall inform veterans who are eligible for housing under section**
17 **42.105 that they are also eligible to receive a voucher for a care facility of their choosing**
18 **under this section.**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

19 **4. The commission shall promulgate rules to implement the provisions of this**
20 **section. Any rule or portion of a rule, as that term is defined in section 536.010, that is**
21 **created under the authority delegated in this section shall become effective only if it**
22 **complies with and is subject to all of the provisions of chapter 536 and, if applicable,**
23 **section 536.028. This section and chapter 536 are nonseverable, and if any of the powers**
24 **vested with the general assembly pursuant to chapter 536 to review, to delay the effective**
25 **date, or to disapprove and annul a rule are subsequently held unconstitutional, then the**
26 **grant of rulemaking authority and any rule proposed or adopted after August 28, 2020,**
27 **shall be invalid and void.**
