## AN ACT

To repeal sections 426.010, 426.020, 426.030, 426.040, 426.050, 426.060, 426.070, 426.080, 426.090, 426.100, 426.110, 426.120, 426.130, 426.140, 426.150, 426.160, 426.170, 426.180, 426.190, 426.200, 426.210, 426.220, 426.230, 426.240, 426.250, 426.260, 426.270, 426.280, 426.290, 426.300, 426.310, 426.320, 426.330, 426.340, 426.350, 426.360, 426.370, 426.380, 426.390, 426.400, and 426.410, RSMo, and to enact in lieu thereof forty-eight new sections relating to the assignment of benefits for creditors.

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Sections 426.010, 426.020, 426.030, 426.040, 426.050, 426.060, 426.070, 2 426.080, 426.090, 426.100, 426.110, 426.120, 426.130, 426.140, 426.150, 426.160, 426.170, 3 426.180, 426.190, 426.200, 426.210, 426.220, 426.230, 426.240, 426.250, 426.260, 426.270, 4 426.280, 426.290, 426.300, 426.310, 426.320, 426.330, 426.340, 426.350, 426.360, 426.370, 5 426.380, 426.390, 426.400, and 426.410, RSMo, are repealed and forty-eight new sections 6 enacted in lieu thereof, to be known as sections 426.500, 426.510, 426.513, 426.516, 426.519, 7 426.522, 426.525, 426.550, 426.553, 426.556, 426.559, 426.562, 426.565, 426.568, 426.600, 8 426.603, 426.606, 426.609, 426.612, 426.615, 426.650, 426.653, 426.656, 426.659, 426.662, 9 426.665, 426.668, 426.671, 426.674, 426.677, 426.680, 426.683, 426.686, 426.689, 426.692, 10 426.695, 426.700, 426.703, 426.706, 426.709, 426.712, 426.715, 426.718, 426.750, 426.753, 11 426.756, 426.759, and 426.762, to read as follows:

**426.500. For the purposes of this chapter, the following terms mean:**

2       **(1) "Abandon", to file and obtain the court's approval of a renunciation of assigned**  
3 **assets, rights, claims, and causes of action. An abandonment shall be effective to the extent**

4 approved by the court as if the assets, rights, claims, and causes of action so abandoned  
5 were never assigned to the assignee;

6 (2) "Affiliate":

7 (a) A person that directly or indirectly owns, controls, or holds with power to vote  
8 twenty percent or more of the outstanding voting securities of the assignor or twenty  
9 percent or more of whose outstanding voting securities are directly or indirectly owned,  
10 controlled, or held with power to vote by the assignor, excluding securities held in a  
11 fiduciary or agency capacity without sole discretionary power to vote, or held solely to  
12 secure a debt if the holder has not in fact exercised the power to vote; or

13 (b) A person that operates the business of the assignor under a lease or operating  
14 agreement or whose business is operated by the assignor under a lease or operating  
15 agreement;

16 (3) "Assets":

17 (a) Any property, real or personal, of a debtor not exempt from liability for its  
18 debts;

19 (b) Any property, real or personal, to the extent that the property is liable for any  
20 debts of a debtor; and

21 (c) Exempt property waived under section 426.606;

22 (4) "Assignment", a document intended to serve as a general assignment for the  
23 benefit of creditors;

24 (5) "Claim":

25 (a) A right to payment, regardless if such right is reduced to judgment, liquidated,  
26 unliquidated, fixed, contingent, matured, unmatured, disputed, undisputed, legal,  
27 equitable, secured, or unsecured; or

28 (b) A right to an equitable remedy for breach of performance if such breach gives  
29 rise to a right to payment, regardless if such right to an equitable remedy is reduced to  
30 judgment, fixed, contingent, matured, unmatured, disputed, undisputed, secured, or  
31 unsecured;

32 (6) "Conveyance", every payment of moneys; assignment, release, transfer, lease,  
33 mortgage, or pledge of tangible or intangible property; or the creation of any lien or  
34 incumbrance;

35 (7) "Creditor", a person that has a claim and includes an assignee of a general  
36 assignment for the benefit of creditors against a debtor or assignor;

37 (8) "Debt", liability on a claim;

38 (9) "General assignment for the benefit of creditors", an assignment that:

39 (a) Is of all the debtor's or assignor's assets that are transferable and not exempt  
40 from enforcement of a monetary judgment; or

41 (b) Is for the benefit of all the debtor's or assignor's creditors and does not create  
42 a preference of one creditor or class of creditors over any other creditor or class of  
43 creditors except those priorities to which certain classes of creditors are entitled under  
44 sections 426.500 to 426.762 or other applicable law;

45 (10) "Governmental unit", a subdivision, agency, department, county, parish,  
46 municipality, or other unit of a county, a state, the United States, or a foreign country.  
47 "Governmental unit" includes a political subdivision or an organization having a separate  
48 corporate existence if the organization is eligible to issue debt on which interest is exempt  
49 from income taxation under the laws of the United States;

50 (11) "Insider":

51 (a) If the debtor or assignor is a natural person:

52 a. A relative of the debtor or assignor or of a general partner of the debtor or  
53 assignor;

54 b. A partnership in which the debtor or assignor is a general partner;

55 c. A general partner of the debtor or assignor; or

56 d. A corporation of which the debtor or assignor is a director, officer, or person in  
57 control;

58 (b) If the debtor or assignor is a corporation or a limited liability company:

59 a. A director, officer, or person in control of the debtor or assignor;

60 b. A partnership in which the debtor or assignor is a general partner;

61 c. A general partner of the debtor or assignor; or

62 d. A relative of a general partner, director, officer, or person in control of the  
63 debtor or assignor;

64 (c) If the debtor or assignor is a partnership:

65 a. A general partner in the debtor or assignor;

66 b. A relative of a general partner in, general partner of, or person in control of the  
67 debtor or assignor; or

68 c. A partnership in which the debtor or assignor is a general partner;

69 (d) An affiliate of the debtor or assignor or an insider of an affiliate as if such  
70 affiliate were the debtor or assignor; or

71 (e) A managing agent of the debtor or assignor;

72 (12) "Person", a natural person, partnership, corporation, limited liability  
73 company, and any other organization, association, or group of individuals that may  
74 voluntarily transfer property or enforce a claim in its own name;

75 (13) "Prime lending rate", the prime lending rate as published in the Wall Street  
76 Journal. In the event that the Wall Street Journal does not then or ceases to report a prime  
77 lending rate, the judge assigned to the main case shall, upon motion, designate another  
78 financial or governmental publication of national circulation to be used to determine the  
79 prime lending rate;

80 (14) "Relative", an individual related by blood or marriage within the third degree  
81 as determined by the common law or an individual in a step or adoptive relationship within  
82 such third degree;

83 (15) "Statutory lien", a lien arising solely by force of a statute on specified  
84 circumstances or conditions or a lien of distress for rent, regardless of whether statutory.  
85 "Statutory lien" shall not include a security interest or judicial lien, regardless if such  
86 interest or lien is provided by or is dependent on a statute and regardless if such interest  
87 or lien is made fully effective by statute;

88 (16) "Transfer", every mode, direct or indirect, absolute or conditional, voluntary  
89 or involuntary, of disposing of or parting with property or with an interest in property,  
90 including retention of title as a security interest;

91 (17) "Wages", all remuneration paid to any employee for his or her employment,  
92 including the cash value of all remuneration paid in any medium other than cash.

426.510. All proceedings under this chapter shall be subject to the order and  
2 supervision of the circuit court for the county of the assignor's residence. The court in all  
3 cases shall have exclusive authority over the assignee; the exclusive possession and right  
4 of control with respect to all real property and all tangible and intangible personal  
5 property so assigned to the assignee, wherever located; and the exclusive authority to  
6 determine all controversies relating to the collection, preservation, application, and  
7 distribution of all property and to determine all claims against the assignee arising out of  
8 the exercise of the assignee's powers or the performance of the assignee's duties.

426.513. Any assignor, other than an individual, making a general assignment shall  
2 be considered, for the purposes of this chapter, a resident of the county in which its  
3 principal office is located. An individual making a general assignment shall be venued in  
4 the county in which the individual resides.

426.516. 1. All matters requiring court authorization under this chapter shall be  
2 brought by motion, except for the following matters that shall be brought by adjunct action  
3 as provided in subsection 2 of this section:

4 (1) An action by the assignee to recover moneys or other assets of the estate;

5 (2) An action by the assignee to determine the validity, priority, or extent of a lien  
6 or other interest in property or to subordinate or avoid an unperfected security interest;

7 (3) An action by the assignee to avoid any conveyance or transfer that is void or  
8 voidable by law under section 426.692;

9 (4) An action by an aggrieved person to assert a claim on the assignee's bond under  
10 section 426.615; or

11 (5) An action to seek a receiver under sections 515.500 to 515.665.

12 2. An adjunct action designated in subsection 1 of this section shall be brought as  
13 follows:

14 (1) The Missouri rules of civil procedure shall apply to adjunct actions, except if  
15 inconsistent with the provisions of this chapter;

16 (2) The clerk of the court shall docket an adjunct action under both the same case  
17 number assigned to the original petition filed by the assignee under section 426.510 and a  
18 separate adjunct action number and shall assign such adjunct action to the same division  
19 and judge assigned to the main case; and

20 (3) All pleadings and other papers filed in an adjunct action shall contain a  
21 separate subcaption and the adjunct action number in addition to the caption and case  
22 number applicable to the main case.

426.519. No creditor shall obtain any priority of payment out of the assets assigned  
2 on any judgment rendered after the filing of a complaint to set aside the assignment if the  
3 assignment is set aside and decreed to be void.

426.522. In all actions to set aside any assignment made by the assignor, the  
2 assignee and assignor shall be indispensable parties and any preferred or unpreferred  
3 creditor may be made a party plaintiff or defendant at any time.

426.525. If any assignment is attacked as fraudulent or void for any reason, it shall  
2 not be necessary to prove that the assignee had knowledge of such fraud or collusion or  
3 notice thereof in order to render the assignment void.

426.550. Any individual, entity, or unincorporated group of individuals that has  
2 capacity, either in its own right or through a representative such as a trustee, to convey real  
3 property by deed in this state may execute an assignment of assets to one or more assignees  
4 in trust for the benefit of creditors in conformity with the provisions of this chapter,  
5 subject to any restrictions on executing such an assignment under other applicable law.

426.553. Any general assignment made by partners in business shall include only  
2 the partnership property.

426.556. An assignment of assets under the provisions of this chapter shall be  
2 subject to chapter 428, as well as the provisions of the law relative to alter ego liability,  
3 piercing the corporate or other entity veil, and other like equitable principles. An  
4 assignment shall not be subject to the provisions of chapter 456, but assignees shall be

5 fiduciaries of the creditors and any other parties in interest of the estate to the extent  
6 consistent with the provisions of this chapter. This chapter shall supersede the common  
7 law of assignments for the benefit of creditors, and all assignments for the benefit of  
8 creditors shall comply with such sections.

2 **426.559.** Assignments shall be administered for the equal benefit of the assignor's  
creditors as provided by section 426.695.

2 **426.562.** Except as otherwise provided in this chapter, no assignment shall be void  
or set aside because of any defect, informality, or mistake therein or in the bond, inventory,  
3 or list of creditors accompanying the same. An assignment may be amended and any such  
4 amendment shall relate back to the time of the execution of the assignment. No mistake  
5 or inadvertent failure to comply with the provisions of this chapter shall void the  
6 assignment.

2 **426.565.** An assignment shall not be cancelled or rescinded except pursuant to court  
order after notice and an opportunity to be heard.

2 **426.568.** The following provisions in an assignment shall be void:

2 (1) A provision that prefers a creditor with respect to a claim arising before the  
3 commencement of the assignment;

4 (2) A provision that provides that the assignment is dependent upon any condition  
5 or contingency or reserves any power of revocation;

6 (3) A provision that provides for the payment of any claim known by the assignor  
7 to be false or fraudulent or that provides for the payment of more upon any claim than is  
8 known to be justly due from the assignor;

9 (4) A provision that confers upon the assignee any power that, if exercised, might  
10 prevent or delay the immediate conversion of the assigned assets, provided that the  
11 assignment may provide reasonable terms and manner of sale to be carried out only so far  
12 as practicable and not prejudicial to the interest of the estate; or

13 (5) Any assignment that fails to transfer all assets of the assignor to the assignee or  
14 reserves any interest or benefit in such assets to the assignor, except as provided in section  
15 **426.606.**

2 **426.600. 1.** Every assignment shall be by an instrument in writing, setting forth the  
following:

3 (1) The name of the assignor and his or her residence and business addresses;

4 (2) The name of the assignee and his or her business address;

5 (3) A full and complete inventory of all of the assignor's estate, real or personal,  
6 and its location; and

7           (4) A statement reasonably detailing the compensation of the assignee and the  
8 purpose of the assignment, including all property exempted from execution under chapter  
9 513 that is being claimed by the assignor and stating the estimated amount of each such  
10 exemption.

11           2. The assignor shall attach the inventory to the assignment, together with a list of  
12 creditors, equity holders, and other parties in interest, which shall include the names,  
13 addresses, cities, states, and postal codes for each person and the amount of that person's  
14 anticipated claim in the assignment proceedings.

15           3. The accuracy of the assignment, together with its attachments, shall be attested  
16 to by the assignor by affixing his or her signature to the assignment under penalty of  
17 perjury. The assent of the assignee, subscribed and acknowledged by him or her, shall  
18 appear in writing, embraced in or at the end of or endorsed upon the assignment, before  
19 the same is recorded.

20           4. Within seven business days after its execution by both the assignor and assignee,  
21 the assignment, together with its attachments, shall be filed in the circuit court where  
22 venue is appropriate. A notice of the assignment identifying the circuit court where the  
23 assignment was filed shall also be recorded by the assignee in the office of the recorder of  
24 any county in which any real property being assigned is located. The recording of the  
25 notice of the assignment shall have the effect of conveying to the assignee both legal and  
26 equitable title to the real property.

          426.603. Purchasers and encumbrancers in good faith and for value, if the notice  
2 of the assignment has not been recorded in the appropriate county, shall take free of the  
3 interest of the assignee. Nothing in this chapter shall prohibit the assignee from pursuing  
4 the proceeds of any conveyance or encumbrance from the assignor.

          426.606. No assignment for the benefit of creditors shall include or cover any  
2 property exempt from levy or sale on execution under law or any property exempt from  
3 being applied to the payment of debts by any legal process under law, unless the exemption  
4 is expressly waived in the assignment.

          426.609. An assignee shall, within three business days after the filing of an  
2 assignment with the court, give bond to be approved by the court in double the amount of  
3 the estate and effects assigned. The bond may be adjusted upon motion, notice, and  
4 hearing.

          426.612. The bond required under section 426.609 shall be conditioned on the  
2 assignee's faithful discharge of the assignee's duties in accordance with orders of the court  
3 and state law. Unless otherwise ordered by the court, the assignee's bond runs in favor of

4 all persons having an interest in the assignment proceeding or property held by the  
5 assignee.

2 426.615. Any person injured by a breach of the condition of the bond required  
under section 426.609 may bring an adjunct action to assert a claim on the bond.

2 426.650. (1) Within thirty days after an assignment is executed, the assignee shall  
publish notice of his or her appointment as assignee in a newspaper published in the  
3 county where the assignment is filed with the court. The assignee shall publish notice of  
4 his or her appointment as assignee once each week for three consecutive weeks.

5 (2) The assignee shall also, within thirty days of the acceptance of the assignment  
6 in writing, give written notice of the assignment by United States mail or electronic mail  
7 to each of the assignor's creditors, equity holders, and other parties in interest as set forth  
8 in the list provided by the assignor under subsection 1 of section 426.600.

9 (3) In the notices given under this section, the assignee shall establish a date by  
10 which creditors are required to file their claims to be able to share in the distribution of  
11 proceeds of the liquidation of the assignor's assets. The date shall be no later than one  
12 hundred eighty days after the date of the first giving of the written notice to creditors and  
13 parties in interest.

2 426.653. The assignee shall be paid a reasonable fee for his or her services from the  
estate. Notwithstanding the terms of the general assignment to the contrary, upon the  
3 assignee, a creditor, an equity holder, or other party in interest filing a motion with the  
4 court, the court shall determine reasonable compensation for services provided by the  
5 assignee.

2 426.656. Upon application and approval by the court, the assignee may employ  
counsel to give advice and prosecute or defend litigation. The assignee may also employ  
3 accountants, appraisers, auctioneers, real estate brokers, or other professionals as deemed  
4 appropriate. Such professionals shall be paid a reasonable fee for their services from the  
5 estate. Upon the assignee, a creditor, an equity holder, or other party in interest filing a  
6 motion with the court, the court may determine reasonable compensation for services  
7 provided by such professionals.

426.659. The assignee may:

2 (1) Sue in his or her representative capacity as such assignee and recover all the  
3 estate, debts, and assets belonging or due to such assignor in the manner and with like  
4 effect as the assignor might or could have done if an assignment had not been made;

5 (2) Take control of all of the estate of such assignor, whether delivered to him or  
6 her or afterwards discovered, and all books, vouchers, and papers relating thereto;



- 7 (3) Upon motion, notice, and approval by the court, settle any and all assigned  
8 claims and causes of action, with full power to, in the discretion of the assignee,  
9 compromise, sue or be sued, and prosecute or defend any of the assigned claim or claims;
- 10 (4) Redeem all mortgages and conditional contracts or other encumbrances and  
11 pledges of personal property;
- 12 (5) Sell property subject to encumbrances, contracts, or pledges;
- 13 (6) Sell property free and clear of all encumbrances under section 426.662;
- 14 (7) Exercise any powers that are granted to a trustee or assignee for the benefit of  
15 creditors under the laws of this state;
- 16 (8) Upon motion, notice, and approval by the court, borrow moneys secured by the  
17 assigned assets;
- 18 (9) Receive at the assignee's address, as he or she directs in writing, all mail of all  
19 classes, hand deliveries, parcel posts and express delivery materials, fax transmissions, and  
20 telegrams directed or addressed to the assignor;
- 21 (10) Upon motion, notice, and approval by the court, abandon assigned assets,  
22 rights, claims, and causes of action; and
- 23 (11) Perform any and all other acts necessary and proper for the orderly  
24 liquidation or other disposition of the assigned rights, claims, and causes of action.

426.662. 1. Upon motion, notice, and approval by the court, the assignee may sell,  
2 lease, or otherwise dispose of all or any part of the assigned assets by public or private sale  
3 or auction, for cash or on credit or for any other good consideration, on such terms as he  
4 or she may deem appropriate in the exercise of reasonable judgment, and may convey and  
5 transfer the assigned assets by good and sufficient deeds, bills of sale, or other instruments  
6 to the purchaser or purchasers, free from claims of the assignment, the assignor, and its  
7 creditors of the estate created hereby.

8 2. At a sale of property under this section, a creditor with a lien against the  
9 property to be sold may credit bid at the sale of the property, meaning that the holder of  
10 such claim may bid at such sale, and, if the holder of such claim purchases such property,  
11 such holder may offset such claim against the purchase price of such property, subject to  
12 payment of applicable transfer or sales tax, if any. The purchaser shall take free and clear  
13 of all liens, claims, encumbrances, and interests, and such liens, claims, encumbrances, and  
14 interests shall attach to the proceeds of the sale in accordance with their priorities.

426.665. The assignee shall dispose of all personal property and real estate and  
2 divide the proceeds thereof among creditors as they may be entitled thereto within a  
3 reasonable time from the date of the assignment and shall make full settlement by that date  
4 unless otherwise ordered by the court.

2           **426.668. 1. The assignee may call the creditors together at any time upon**  
3 **reasonable notice and such meetings may be continued from time to time at the discretion**  
4 **of the assignee.**

5           **2. The assignee shall, in conjunction with any meeting called under subsection 1 of**  
6 **this section, compel the assignor to submit to an examination by the assignee and creditors**  
7 **under oath concerning the acts, conduct, assets, liabilities, and financial condition of the**  
8 **assignor or any matter related to the assignee's administration of the assignment estate.**

9           **3. The court may compel the appearance of the assignor or any other person as may**  
10 **be requested by the assignee.**

**426.671. Every assignee, no less than quarterly, shall file a written report with the**  
2 **court stating the condition of the remaining assets of the assignment, reporting the**  
3 **disposition of any and all assets of the assignment since commencement of the assignment,**  
4 **all sums received therefrom, all disbursements made from the funds so received, and such**  
5 **other information as shall be reasonably requested by the court, a creditor, or other party**  
6 **in interest. Upon request of a creditor or other party in interest, the assignee shall make**  
7 **an electronic copy of the most recent report available to such creditor or party in interest.**

**426.674. The proceeds arising from the sales of the property assigned shall be**  
2 **deposited for safekeeping in a national bank within this state, or a banking institution**  
3 **incorporated under the laws of this state, in the name of the assignee or assignees and in**  
4 **trust for the benefit of the assignor's creditors.**

**426.677. A majority of the unsecured creditors of the assignor, in number and**  
2 **amount, may agree in writing upon an assignee different from the one named in the**  
3 **assignment for good cause shown. Such substitute assignee shall be substituted in lieu of**  
4 **the original assignee with all of the rights, powers, and duties conferred upon such original**  
5 **assignee in the assignment. A motion for substitution shall be filed no later than sixty days**  
6 **following the filing of the inventory.**

**426.680. 1. The court shall remove or replace the assignee on application of the**  
2 **assignor, of the assignee, or of any creditor or on its own motion:**

3           **(1) If the assignee has not executed and filed the bond required by section 426.609;**

4           **(2) If the assignee resigns, refuses, or fails to serve for any reason; or**

5           **(3) For good cause.**

6           **2. Upon removal, resignation, or death of the assignee, the court shall appoint a**  
7 **replacement assignee if the court deems in its discretion that further administration of the**  
8 **estate is required. Upon executing and filing a bond under section 426.609, the**  
9 **replacement assignee shall take possession of the estate and assume his or her duties as**  
10 **assignee.**

11           **3. If the court is satisfied that the assignee so removed or replaced has fully**  
12 **accounted for and turned over to the replacement assignee appointed by the court all of**  
13 **the property of the estate and has filed a report of all receipts and disbursements during**  
14 **his or her tenure as assignee, the court shall enter an order discharging the assignee from**  
15 **all further duties, liabilities, and responsibilities as assignee after notice and a hearing.**

**426.683. The assignee shall have the right to occupy, for a period of up to ninety**  
2 **days after the date of the assignment, any business premises held under a real estate lease**  
3 **by the assignor, notwithstanding any provision in the lease to the contrary, whether**  
4 **previously or subsequently entered into, for the termination thereof upon the making of**  
5 **the assignment or the insolvency of the lessee or other condition relating to the financial**  
6 **condition of the lessee. The assignee's right to occupy the premises shall be conditioned**  
7 **upon payment when due of the monthly rental reserved in the lease for the period of such**  
8 **occupancy. If the assignee believes that more than ninety days is necessary to complete his**  
9 **or her duties at the leased premises, the assignee may extend the period of occupation**  
10 **mentioned herein either by agreement with the landlord or by court order entered after**  
11 **appropriate motion, notice, and hearing for such extension for a reasonable time upon**  
12 **conditions that protect the landlord's interests in the premises. In a hearing under this**  
13 **section, the assignee shall have the burden of proof to show good cause for the extension**  
14 **and to show that, under the circumstances, the equities favor the assignee's request for**  
15 **such extension, which may include, but not be limited to, all the benefits and burdens that**  
16 **will accrue to both the assignee and the landlord. At any time after the date of the**  
17 **assignment, the landlord may seek from the court, by appropriate motion, notice, and**  
18 **hearing, emergency modification or termination of the assignee's occupation of the**  
19 **premises in the event of threat of damage to the property or other breach of the conditions**  
20 **that the assignee shall satisfy. The assignee's occupation of premises under this section, for**  
21 **the period authorized herein, shall not be deemed to be a tenant's "holding over", as that**  
22 **term is defined under section 441.080. Any security deposit held by the landlord shall only**  
23 **be applied to claims arising from the breach of the lease prior to the date of the execution**  
24 **of the general assignment.**

**426.686. Subject to other provisions of this chapter, or of other applicable law, an**  
2 **assignee for the benefit of creditors takes assets subject to the rights of persons other than**  
3 **the assignor. Nothing in this section shall be deemed to limit or preclude the assignee from:**

4           **(1) Seeking avoidance of transfers, recovery of property, or declarations of**  
5 **priorities in assets;**

6           **(2) Defending against claims of third persons in estate assets or against the**  
7 **assignee; or**

8           (3) Seeking any other relief or asserting any other defense, offset, or counterclaim  
9 that the assignee is otherwise authorized to seek or assert by applicable law.

          426.689. The assignee shall not be held liable for acts done in good faith and with  
2 the reasonable exercise of business judgment in the execution of the trust.

          426.692. The assignee shall succeed to all rights of the assignor, including any  
2 attorney-client privilege. An assignee may assert on behalf of the estate any claims to avoid  
3 fraudulent transfers that any creditor may assert under state or federal law and may set  
4 aside any fraudulent conveyances or recover property conveyed by the assignor for the  
5 purpose of hindering, delaying, or defrauding creditors. The assignee's rights in this  
6 section shall be exclusive. If the assignee does not exercise such rights, a creditor may  
7 resume the power to exercise them upon motion, notice, and court approval. If the assignee  
8 exercises such rights, the transferee and any creditor that could have asserted them shall  
9 be bound by the results.

          426.695. 1. Allowed claims shall receive distribution under this chapter in the  
2 following order of priority and, with the exception of subdivision (1) of this subsection, on

3 ~~discharge the trust confided to him, and shall proceed to examine the claim, and~~  
4 ~~if the same shall be found to be correct, in whole or in part, he shall allow the~~

10 a date to be fixed by the judge; and the court shall make an order directing the  
11 sum allowed to be paid to the claimant as other allowances are paid, and appeals

2 [426.260. Whenever it shall be made to appear to the court having  
3 jurisdiction that any assignee has neglected or refused, when required by law, to  
4 file a full and true inventory, or to give bond, as required by this chapter, the  
5 court shall issue a citation to such assignee to appear in court at the time therein  
6 specified, to show cause why he should not be dismissed from his trust.]

2 [426.270. On the return of the citation, the court may require the assignee  
3 to file an inventory and to give bond, with good and sufficient security, in such  
4 time as it may deem reasonable, or may proceed at once to dismiss such assignee  
5 from his trust.]

2 [426.280. The like proceedings as are prescribed in sections 426.260 and  
3 426.270 may be had whenever it shall appear to the court that any person who  
4 shall have become security for any assignee, in any bond given for the due  
5 execution of his trust, has or is likely to become insolvent, or has removed, or is  
6 about to remove from the state.]

2 [426.290. The court having jurisdiction, or the judge thereof in vacation,  
3 shall have power to appoint an assignee in all cases where a vacancy occurs in the  
4 trust, and like bond and security shall be required and given by the assignee so  
5 appointed as are required and given by an assignee appointed by an assignor.]

2 [426.300. When any assignee shall be dismissed from his trust, the court  
3 shall order all the books, papers, effects, moneys and evidences of debt to be  
4 forthwith delivered to his successor in the trust, or to such other persons as the  
5 court shall appoint to receive the same for the time being.]

2 [426.310. The circuit court shall make an order for the sale of all the real  
3 and personal estate conveyed by any deed of assignment, either for cash in hand,  
4 or upon such reasonable credit and upon such other terms and notice as shall

4 appear to the court to be most advantageous to all the parties in interest, and  
5 shall, by order, direct the nature of the security to be taken at sales made by  
6 assignees under this chapter. Before any sale of such real estate shall be made,  
7 the assignee shall give bond, with at least two good securities, to be approved by

9 that the said assignee will faithfully make the same under such order, and duly

2 ~~[426.340. Upon petition in behalf of any such person to the circuit court~~

5 ~~trustee in a deed of trust, or an attachment or execution creditor with a writ levied~~
