AN ACT

To amend chapter 164, RSMo, by adding thereto one new section relating to tax levies.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 164, RSMo, is amended by adding thereto one new section, to be
2 known as section 164.075, to read as follows:

**164.075. 1. Beginning January 1, 2022, every school district levying a property tax
2 as part of its operating levy or debt service levy as authorized under the provisions of
3 chapter 137, this chapter, and the Constitution of Missouri shall submit to the voters
4 residing in such school district a ballot question on whether the school district shall provide
5 property tax credits to certain individuals who are liable for such property tax, according
6 to the provisions of this section. Notwithstanding any provision of law to the contrary, if
7 a ballot question receives approval from the voters in a school district, the property tax
8 credits shall be funded directly by an increase in the property tax levied by such school
9 district on all taxpayers who reside within the school district who do not receive the
10 property tax credit.**

**11 2. Any tax credit issued to an individual by a school district under this section shall
12 be issued in an amount equal to the amount of total property tax levied on a house located
13 within such school district that has an assessed valuation equal to the median assessed
14 valuation of houses in such school district.**

**15 3. Any school district that receives voter approval for the property tax credit
16 authorized in this section shall provide such property tax credit to all individuals seventy-
17 five years of age or older residing in the district and to no other individuals.**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

18 **4. The ballot question submitted by school districts under this section shall contain**
19 **substantially the following language:**

20 **Shall the school board of _____ (name of district) be authorized to**
21 **provide a tax credit to individuals seventy-five years of age or older against**
22 **the amount of property tax for which such individuals are liable under the**
23 **current operating levy and debt service levy of _____ (name of**
24 **district)? The amount of such a tax credit shall be equal to the amount of**
25 **property tax that would be levied under the current operating levy and debt**
26 **service levy of _____ (name of district) on a home located in the**
27 **district with an average market value and shall be funded by increasing the**
28 **current operating levy and debt service levy on those individuals residing in**
29 **the district who do not receive the tax credit.**

32 **If a majority of the votes cast on the ballot question are in favor, the school district shall**
33 **provide tax credits to individuals seventy-five years of age or older, as provided under this**
34 **section, for a period of ten years, and the school district shall increase the property tax that**
35 **it levies on all other persons residing in the district to such a rate that would offset the cost**
36 **of providing the tax credits. If the ballot question does not receive a majority of votes cast**
37 **in its favor, the school district shall not provide tax credits under this section and the**
38 **property tax levied by the school district shall remain at the existing rate for all**
39 **individuals.**

40 **5. Regardless of whether the ballot question under subsection 4 of this section**
41 **receives voter approval, every school district shall resubmit the same proposal for voter**
42 **approval ten years after the first ballot question is submitted and every ten years**
43 **thereafter. The provisions of subsection 4 of this section shall apply to all resubmissions**
44 **of ballot questions by school districts.**

45 **6. Tax credits issued under this section shall not be refundable and shall not be**
46 **carried forward to a subsequent property tax year. Tax credits issued under this section**
47 **shall not be assigned, transferred, sold, or otherwise conveyed.**

48 **7. School districts shall collaborate with the officials of the counties in which they**
49 **are located, or the officials of the city not within a county in which they are located, to**
50 **administer the provisions of this section.**
