But, in situations where this is not permitted I should, at the very least, have the option to have it locked up as nearby to me as possible. I especially like the idea of an employer providing secure storage areas for firearms if the lot is to be restricted. This actually reminds me of a situation I find myself subject to when visiting the capitol to give testimony at public hearings. The law governing firearms within the Capitol allows me to carry concealed within the building, but not into the hearing rooms. As such, I am forced to walk to and from my car unarmed, sometimes after dark. Being a petite woman who takes her personal safety quite seriously I do not appreciate this and would love for a storage area to be made available to those like me who desire not to be stripped of our Second Amendment rights beyond this building in order just to exercise our First. As I began, on body is the most secure place for a CCW permit holder's weapon to be. But, allowing it to remain locked in our vehicles as near to the door as possible is a more than reasonable compromise. Those who choose to carry firearms for self-defense deserve to have laws on the books which support this lifestyle instead of being road blocks to it. I urge the Committee members to vote in support of HB737. My name is Benjamin Cohen. I'm a senior at Hickman High School and a leader in Columbia's citywide Students Demand Action group. I'm grateful for the opportunity to share written testimony in opposition to HB 737. Under current Missouri law, it's unlawful to bring guns into parking lots for many public and private businesses, schools, and organizations without the consent of that organization or private business. House bill 737 would allow people to carry hidden, loaded guns in vehicles onto the property of all public and private organizations whose rules keep their property safe from guns. If enacted, this extreme bill would force private property owners to allow guns in cars on their property. This bill would vastly expand the places where firearms are legally allowed in Missouri, multiplying the public places where people would fear the threat of gun violence. This bill would significantly affect the safety and autonomy of many of the places I have grown up in, including schools I attended for years. The idea that guns would be forced into these spaces without consent from owners or administrators is deeply troubling, and frightens me on behalf of kids who would have to grow up with HB 737 in place. Guns do not belong in our educational facilities, including parking lots. Gun ownership is a personal decision. Firearm safety, specifically safe storage and transportation, are responsibilities that are inherent in that decision. But the decision to allow firearms on one's property must also be a personal decision—one made by property owners. Please vote no on this dangerous bill.

I oppose HB 568 which would make Missouri one of a small minority of states to force colleges and universities to allow handguns on their campuses. The suicide rates in MO among the 10-24 age group is up 105% over the last decade. Missouri's gun homicide rate is worse than all but two other states and is more than twice as high as the national average. • With a rate of 6.63 gun deaths for every 100,000 people among people under the age of 21, the state ranks third in the nation. • In Missouri, shootings are the leading cause of death for young people. Colleges and universities, which have traditionally prohibited guns on campus, are relatively safe from gun violence. But campus life is rife with other risk factors that make the presence of guns potentially dangerous – including heavy alcohol and drug use, mental health issues and suicide. Please vote for the welfare of our youth, the safety of our college and university campuses. The numbers in Missouri tell us we need to do things differently to protect our youth and all citizens. More people carrying more guns in more places is not going to make us safer, and private property owners should be able to completely restrict firearms on their property.
