## AN ACT

To repeal section 304.820, RSMo, and to enact in lieu thereof one new section relating to the use of electronic wireless communications devices, with penalty provisions.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Section 304.820, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 304.822, to read as follows:

**304.822. 1. As used in this section, the following terms mean:**

(1) "Electronic message", a self-contained piece of digital communication that is designed or intended to be transmitted via an electronic wireless communications device, which includes, but is not limited to, electronic mail, a text message, an instant message, or a command or request to access an internet site;

(2) "Electronic wireless communications device", includes, but is not limited to, a cell phone, personal digital assistant, electronic device with mobile data access, laptop computer, pager, broadband personal communications device, electronic game, or portable computing device. An "electronic wireless communications device" shall not include:

(a) A global navigation satellite system receiver used for positioning, emergency notification, or navigation purposes; or

(b) Two-way or citizens band radio services;

(3) "Hands-free electronic wireless communications device", a wireless communications device that has an internal feature or function, or that is equipped with an attachment or addition, regardless of whether permanently part of such mobile electronic device, by which a user engages with the device without the use of either

18 hand; provided, however, this definition shall not preclude the use of either hand merely  
19 to activate, deactivate, or initiate a function of the device;

20 (4) "Highway", any public thoroughfare for vehicles, including state roads,  
21 county roads, public streets, avenues, boulevards, parkways, or alleys in any  
22 municipality;

23 (5) "Operating", physically driving or operating a motor vehicle on a highway,  
24 including operation while temporarily stationary because of traffic, a traffic light or  
25 stop sign, or otherwise. A person is not "operating" a motor vehicle for purposes of this  
26 section when the vehicle has pulled over to the side of, or off, a highway and has stopped  
27 in a location where it can safely remain stationary.

28 2. Except as otherwise provided in this section, a person operating a  
29 noncommercial motor vehicle, as such term is defined in section 302.700, upon the  
30 highways of this state shall not use any hand-held electronic wireless communications  
31 device while operating such vehicle. Prohibited uses shall include, but not be limited to:  
32 reading, composing, viewing, or posting any electronic message; initiating, receiving, or  
33 conducting a conversation; or manually typing data into any electronic wireless  
34 communications device.

35 3. Except as otherwise provided in this section, no person shall operate a  
36 commercial motor vehicle, as that term is defined in section 302.700, while using a hand-  
37 held mobile telephone.

38 4. Except as otherwise provided in this section, no person shall operate a  
39 commercial motor vehicle, as that term is defined in section 302.700, while using an  
40 electronic wireless communications device to send, read, or write a text message or  
41 electronic message.

42 5. The provisions of subsections 2 to 4 of this section shall not apply to a person  
43 operating:

44 (1) An authorized emergency vehicle as defined in section 304.022;

45 (2) A motor vehicle that is responding to another motor vehicle's request for  
46 roadside assistance upon the highways of this state when such response is conducted in  
47 the course and scope of a commercial activity; or

48 (3) A motor vehicle while using a hand-held electronic wireless communications  
49 device to:

50 (a) Contact emergency services; or

51 (b) Relay information between a transit or for-hire motor vehicle operator and  
52 that operator's dispatcher when the device is affixed to the motor vehicle.

53 6. Nothing contained in subsection 2 of this section shall be construed or  
54 interpreted to prohibit a person operating a noncommercial motor vehicle, as such term

55 is defined in section 302.700, on the highways of this state from using a hands-free  
56 electronic wireless communications device when the operator is not holding the hands-  
57 free electronic wireless communications device in the operator's hand or hands, except  
58 the operator shall not have his or her attention diverted from the lawful operation of the  
59 noncommercial motor vehicle. The provisions of subsection 2 shall not prohibit the use  
60 of either hand merely to activate, deactivate, or initiate a function of a hands-free  
61 electronic wireless communications device while operating a noncommercial motor  
62 vehicle.

63 7. A violation of this section shall be deemed an infraction punishable by a fifty-  
64 dollar fine. A violation of this section while operating a motor vehicle in a work zone, as  
65 defined in section 304.580; when highway workers, as defined in section 304.580, are  
66 present; or in areas designated as a school zone that are visibly marked by traffic  
67 control devices shall be deemed an infraction punishable by a one-hundred-dollar fine.  
68 A violation of subsection 2 of this section shall not be deemed a moving violation for  
69 purposes of point assessment under section 302.302; however, a violation of subsection 3  
70 or 4 of this section shall be deemed a serious traffic violation, as defined in 302.700, for  
71 purposes of commercial driver's license disqualification under section 302.755.

72 8. The state preempts the field of regulating the use of hand-held electronic  
73 wireless communications devices by the operators of motor vehicles, and the provisions  
74 of this section shall supersede any local laws, ordinances, orders, rules, or regulations  
75 enacted by a county, municipality, or other political subdivision to regulate the use of  
76 hand-held electronic wireless communications devices by the operator of a motor  
77 vehicle.

78 9. Notwithstanding any provision in this section to the contrary, no person less  
79 than eighteen years of age, or with an instruction permit or intermediate license  
80 regardless of age, shall use an electronic wireless communications device, regardless of  
81 whether such device is hands-free, while operating a motor vehicle on the highways of  
82 this state, except to contact emergency services.

21           5. ~~Nothing in this section shall be construed or interpreted as~~  
22 ~~prohibiting a person from making or taking part in a telephone call, by means~~  
23 ~~of a hand held electronic wireless communications device, while operating a~~  
24 ~~noncommercial motor vehicle upon the highways of this state.~~

25           6. ~~As used in this section, "electronic message" means a self contained~~  
26 ~~piece of digital communication that is designed or intended to be transmitted~~  
27 ~~between hand held electronic wireless communication devices. "Electronic~~  
28 ~~message" includes, but is not limited to, electronic mail, a text message, an~~  
29 ~~instant message, or a command or request to access an internet site.~~

30           7. ~~As used in this section, "hand held electronic wireless~~  
31 ~~communications device" includes any hand held cellular phone, palm pilot,~~  
32 ~~blackberry, or other mobile electronic device used to communicate verbally or~~  
33 ~~by text or electronic messaging, but shall not apply to any device that is~~  
34 ~~permanently embedded into the architecture and design of the motor vehicle.~~

35           8. ~~As used in this section, "making or taking part in a telephone call"~~  
36 ~~means listening to or engaging in verbal communication through a hand held~~  
37 ~~electronic wireless communication device.~~

38           9. ~~As used in this section, "send, read, or write a text message or~~  
39 ~~electronic message" means using a hand held electronic wireless~~  
40 ~~telecommunications device to manually communicate with any person by~~  
41 ~~using an electronic message. Sending, reading, or writing a text message or~~  
42 ~~electronic message does not include reading, selecting, or entering a phone~~  
43 ~~number or name into a hand held electronic wireless communications device~~  
44 ~~for the purpose of making a telephone call.~~

45           10. ~~A violation of this section shall be deemed an infraction and shall~~  
46 ~~be deemed a moving violation for purposes of point assessment under section~~  
47 ~~302.302.~~

48           11. ~~The state preempts the field of regulating the use of hand held~~  
49 ~~electronic wireless communications devices in motor vehicles, and the~~  
50 ~~provisions of this section shall supercede any local laws, ordinances, orders,~~  
51 ~~rules, or regulations enacted by a county, municipality, or other political~~  
52 ~~subdivision to regulate the use of hand held electronic wireless~~

54           12. ~~The provisions of this section shall not apply to:~~  
55           ~~(1) The operator of a vehicle that is lawfully parked or stopped;~~

57 ~~duties: a law enforcement officer; a member of a fire department; or the~~  
58 ~~operator of a public or private ambulance;~~

- 59                   ~~(3) The use of factory installed or aftermarket global positioning~~
- 60 ~~systems (GPS) or wireless communications devices used to transmit or receive~~
- 61 ~~data as part of a digital dispatch system;~~
