### **PERFECTION OF HOUSE BILLS - INFORMAL**

AMEND House Bill No. 730, Page 1, In the Title, Lines 2-3, by deleting the words "a moratorium on eviction proceedings" and inserting in lieu thereof the words "property rights"; and

This provision shall not apply to any inspection requirement of new construction or occupancy permits.";** and
