





If you have been impacted by the recent changes in Missouri's prescription drug program for seniors, you may find helpful information below.

The Department of Social Services offers other suggested resources to help with prescription drug costs:

MO HealthNet (Medicaid) To see if you qualify, call the Family Support Division at (855) 373-4636.

Medicine Assistance Tool (MAT) The MAT helps the uninsured and under-insured get prescription medications from existing patient assistance programs. Find MAT online at medicineassistancetool.org.



Rx Outreach Rx Outreach is a nonprofit mail order pharmacy that provides affordable medications for people in need. To find out if you qualify, call (888) 796-1234 or online at rxoutreach.org.

### TAX RELIEF FOR MISSOURI SENIORS AND DISABLED

**The Missouri Property Tax Credit** allows a credit to certain senior citizens and 100% disabled individuals based on total household income (taxable and nontaxable) and the amount of property taxes or rent paid. The credit is for a maximum of \$750 for renters and \$1,100 for those who own and occupy a home.

### To be eligible a person must be:

- 65 years of age or older,
- 60 years of age or older and receiving Social Security surviving spouse benefits, or
- 100% disabled

The maximum income level to qualify: OWNED AND OCCUPIED HOME

FOR ENTIRE YEAR Single - \$30,000

Married filing jointly - \$34,000

RENTERS/PART YEAR OWNERS Single - \$27,500

Married filing jointly - \$29,200
